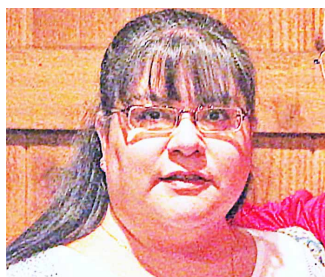

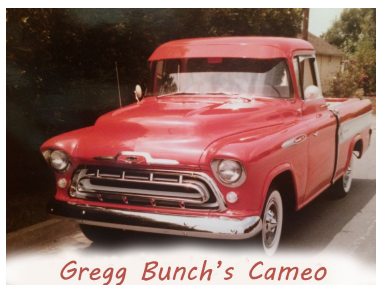

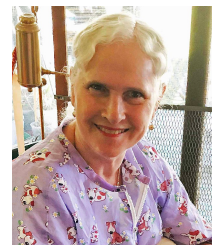

Mark and Arlene are true gems. From the moment I met Mark at the Orange Plaza car show on April 23, 2006, I immediately thought he was a great guy!

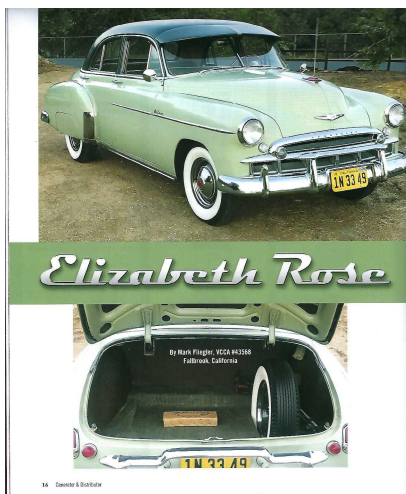

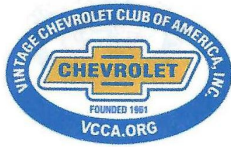
--- **Jim Karras:**
